We want your child to be safe, happy and enjoy learning at school. If you have a concern or problem there are things you can do:

Talk to the teacher. It may be possible to resolve things with a quick word. If it needs more time an appointment can be made.

Talk to the Head of School.

They are usually available at the start and end of the day for a quick word, or you can make an appointment at the office. The Head of School may suggest you meet with the Executive Headteacher.

Talk to a Governor. Governors try to attend school events when possible. You can make an appointment to speak to a governor at the office.

If you are unsure about what to do or who to approach, please ask at the school office who will be happy to advise you.

Please let us know:

Straight away if your child is ill and has to miss school (If your child has been sick or had diarrhoea they must remain off school for 48 hours after the last incident).

As soon as possible if you are delayed at the end of the day or someone different is collecting your child so we can keep your child safe.

In advance if you need to take your child to a medical appointment—please ensure you provide proof of an appointment.

In advance if absence due to a holiday in term time is unavoidable—please ensure you fill in a holiday form.

Straight away of any changes in your contact details—we need to ensure these are kept up to date in case we need to contact you quickly.
