Your views and opinions are very important to us as we make decisions about future improvements to our schools.

Here is a brief overview of the responses you gave and some of things we have already planned to address the few concerns that were raised.

At Least 95%

Of parents/carers felt:

- Their child was happy at school
- · Their child is safe and well cared for
- The school makes sure their child behaves well
- Their child does well at school
- They are well informed about key events
- They could contact their child's teacher
- They felt able to speak to the Heads of Schools

You said: A few parents commented that they would prefer longer or later parent/teacher meetings and a few preferred face-to-face meetings

Our response: Virtual meetings ensure time is allocated to every family fairly and meetings do not overrun. They also make it much easier for many parents to attend without having to arrange childcare.

We will continue to offer time in class with books the week before your meetings and remind you again that you can book a meeting with your child's teacher at any time if you have a specific question or concern.

Next year, we are hoping to offer one later evening slot to accommodate more working parents.

You said: A few parents commented that you would like more clubs, activities and wider opportunities for your child

Our response: We agree! We have begun this year to offer more outside of the curriculum and are working with some families to finalise our offer for next year.

There has been very limited uptake of paid-for clubs in the past. Our teachers are not paid to run the clubs they lead so we cannot offer more free clubs. What we will do is review the range of free clubs we offer and ensure clubs like football are equal for both boys and girls.

We are proud of our new cycling offer and in-school offers like fencing and live theatre. We also have big plans for lunchtime activities coming soon!

At Least 90%

Of parents/carers felt:

- They know what their child learns at school
- Concerns are dealt with properly, including any concerns related to bullying
- Children with SEND are well supported
- The school has high expectations for their child
- Parent/Teacher meetings are useful
- Information sent home is useful
- Their child enjoys break and lunch times
